

ARTICLES OF INCORPORATION



ARTICLE I - NAME

The name of this corporation is Pat's Floor & Carpet Cleaning Services, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 316 Oregon Street Hollywood, Florida 33019

ARTICLE III - PURPOSE
