Article I - Name

The name of the corporation is CREATIVE FLEX, INC.

Article II - Duration

The corporation shall have perpetual existence and this existence shall commence on the date of execution and acknowledgment of these articles.

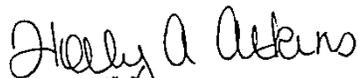
