Article I - Name

The name of the corporation is CREATIVE FLOW, INC.

Article II - Duration

The corporation shall have perpetual existence and this existence shall commence on the date of execution and attestation of these articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

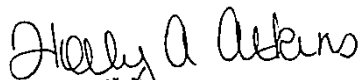
