The corporation may transact any and all lawful business of which corporations may be incorporated under the Laws of the State of Florida.

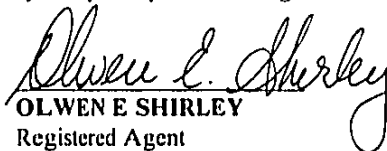
ARTICLE FOUR

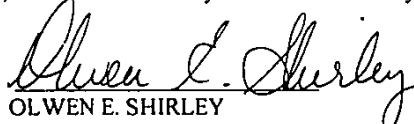
