

INFORMAL ACTION OF DIRECTORS**


If all the directors separately or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the

AMENDMENTS OF ARTICLES**



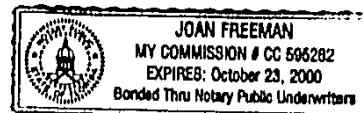
