

ARTICLE I - NAME

The name of this Corporation is NUTRILINK CORPORATION

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on February 28, 1997.





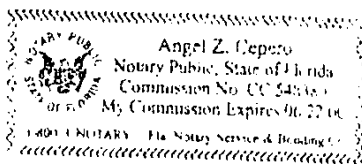
