ARTICLES OF INCORPORATION OF

SECRETARY L. STATE TALLAHASSEE, FLORIDA

SANCTUARY HUNT CLUB, INC.

ARTICLE I - NAME

The name of this corporation shall be SANCTUARY HUNT CLUB, INC., and the address of the principal office of the corporation is 133 East Indiana Avenue, DeLand, FL 32724.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.
