The corporation shall exist in perpetuity unless dissolved in accordance with Florida law.

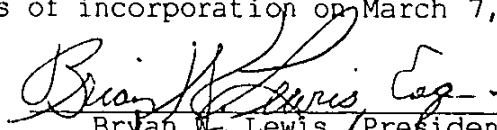
ARTICLE VII. NATURE AND SCOPE OF ACTIVITIES

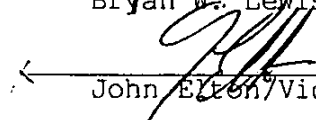

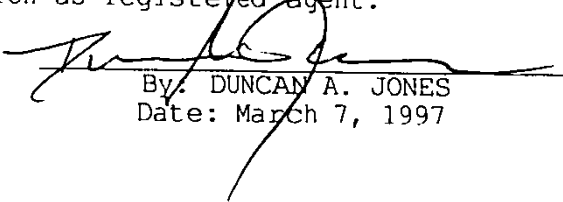
