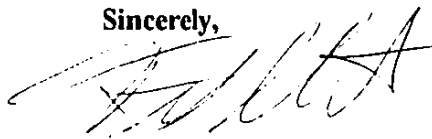

**ARTICLES OF INCORPORATION**

THE UNDERSIGNED, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I: NAME**

The name of this corporation is LAKE CITY TOWER, INC..

**ARTICLE II: DURATION**

The period of its duration is perpetual.

**ARTICLE III: NATURE OF BUSINESS**

The purpose of this corporation is to engage in any activities or businesses permitted under the laws of the United States and State of Florida, except that this corporation shall not conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone, or cemetery company, a building or loan association, mutual fire insurance association, cooperative association, fraternal benefits society, state fair or exposition.

**ARTICLE IV: CAPITAL STOCK**

The corporation is allowed to have outstanding at any one time 1,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE V: INITIAL REGISTERED AGENT**

The power to adopt, alter, amend, or appeal the By-Laws of this corporation shall be vested in the shareholders.

**ARTICLE XI: NON-RESIDENT DIRECTORS**

Directors need not be residents of this state or shareholders unless Articles of Incorporation or By-Laws so require.

**ARTICLE XII: RESTRICTION ON AUTHORITY  
TO MORTGAGE OR PLEDGE ASSETS**

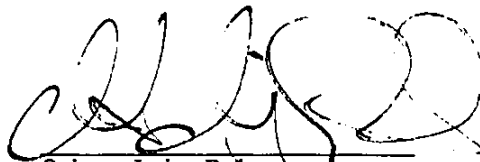
The Board of Directors of the corporation may not authorize any mortgage or pledge of, or creation of a security interest in, any or all of the property and assets of the corporation for the purpose of securing the payment or performance of any obligation of the corporation, without obtaining prior shareholder approval of any and each such transaction by the vote or written consent of

the holders of 51% of the shares of the corporation entitled to vote thereon and not otherwise.

**ARTICLE XIII: INFORMAL ACTION OF DIRECTORS**

If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

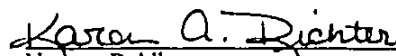

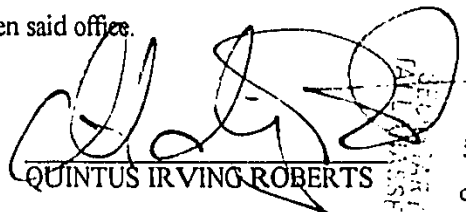
