- All Amendments included herein were adopted effective March 24, 1998 pursuant to Section 607.1004, F.S., and there is no discrepancy between the Articles of Incorporation as theretofore amended other than the inclusion and deletion of the Amendments statement above and the omission of matters of historical interest.
