

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is IMS PROPERTY INSPECTION SERVICES, INC. The address of the principal office of this corporation shall be 1101 - 6th Avenue West, Suite 120, Bradenton, Florida 34205, and the mailing address shall be the same.


