ARTICLES OF INCORPORATION

OF

BRANTECH CONSULTING, INC.

The undersigned, under the Florida General Corporation Act, adopts the following

Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is BranTech Consulting, Inc.
