ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is EIB CONSULTING, INC.

ARTICLE II

Principal Office
