## ARTICLES OF INCORPORATION OF BUCKINGHAM PROPERTIES, INC.

THE UNDERSIGNED, acting as sole incorporator of BUCKINGHAM PROPERTIES, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

## ARTICLE I


