

The undersigned incorporator, GEORGE BERMAN, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

1. The name of the corporation shall be:


GEORGE BERMAN CUSTOM CABINETS, INC.


