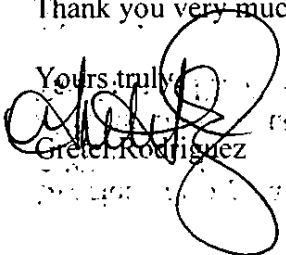
As per our telephone conversation on Friday, April 7, 2006, enclosed please find a check in the amount of \$165.00 regarding the above-referenced entity.
