The Articles of Incorporation of ORLANDO BROADCAST PARTNERS, INC., a Florida corporation, were filed on March 11, 1997 and assigned Charter No. P97000021914.

The sole Director of the corporation has approved in a Written Consent to Action of Sole Director Taken in Lieu of a Special Meeting dated March 15, 1999, that the corporation's Articles of Incorporation be amended and restated. The Corporation has not issued shares of common stock of the Corporation and shareholder approval of these Amended and Restated Articles of Incorporation will not be required. Therefore, the Articles of Incorporation of the corporation are amended and restated to read as follows:

ARTICLE I - NAME


ARTICLE V - BOARD OF DIRECTORS
