## ARTICLES OF INCORPORATION

OF

### ARTICLE I NAME

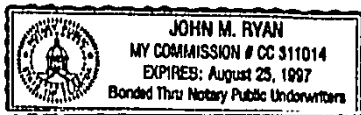




