ARTICLE I. NAME

The name of this Corporation is MALIBU TRANSPORTATION, INC., and the address is 11500 Westwood Blvd., Apt 1624, Orlando, FLORIDA 32821.

ARTICLE II. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III. NATURE OF BUSINESS
