

ARTICLE I - NAME

The name of this Corporation is Mobile Relay 900, Inc.
The mailing address is: 1461 Banks Road, Margate, Florida 33063.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on March 1, 1997.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.


