The undersigned, for the purpose of forming a corporation for profit under the laws gRIDA Florida, adopts the following Articles of Incorporation:

Article I Name EFFECTIVE DATE

Section 1.1. Name. The name of this corporation shall be Dial-4-Less, Inc.

Article II Principal Office and Mailing Address
