# ARTICLES OF INCORPORATION OF

#### **Capstone Communications, Inc.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

#### **ARTICLE I**

#### **NAME**

The name of the corporation shall be Capstone Communications, Inc.

Any of the directors of the corporation may vote upon any and all truncations with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
