ARTICLE I - NAME

The name of the corporation is: **AUTO ELECTRICAL & MECHANICAL SERVICES, INC.**

ARTICLE II - PURPOSES

This corporation is organized for the following purposes:

A. To such extent as a corporation organized under the Business Corporation Law of this state may now or hereafter lawfully do, including but not limited to specialists in Armatures, A.C & D.C. motors, generators, welding machines, transformers, battery charges, electronics P.C. boards, industrial maintenance & fault finding of control system; specialists in mechanical, auto repairs & servicing of cars; servicing and repairs of air conditioners, fridges, cold rooms, water coller and air cooler, either as principal or agent and either alone or in connection with other corporations, firms or individuals, all and everything necessary, suitable, convenient or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this Corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now

or hereafter be organized to do or to exercise under the Business Corporation Law of this state or under any act amendatory thereof, supplemental thereto, or substituted therefor.

This corporation is authorized to issue Five Hundred (500) shares of common stock without nominal or par value.

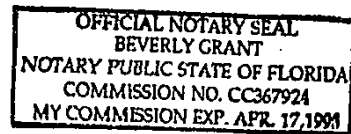

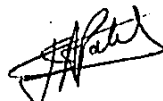
