THE UNDERSIGNED, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be **PSALMS CORPORATION**. The principal office of the corporation is **2000 North Volusia Avenue, Orange City, Florida 32763** and the mailing address of the corporation is **2000 North Volusia Avenue, Orange City, Florida 32763**.

**ARTICLE II
DURATION**

The term of existence is perpetual.

CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is **six hundred (600)** shares and each share shall be the par value of **\$1.00**. 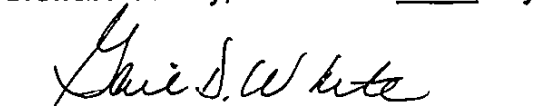

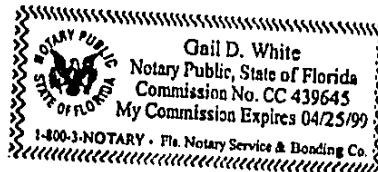
