

ARTICLE 1

N A M E

The name of this Corporation is P. D. I. S. CORPORATION

ARTICLE II

NATURE OF BUSINESS

This Corporation is being formed to conduct any and all business activities permitted by the laws of the State of Florida, and to generally have and exercise all powers, rights and privileges necessary and incident to carry out properly the objects herein mentioned.

TERMS OF EXISTENCE



Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgement, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceeding, whether civil, criminal, administrative or investigative, and any appeals thereof, which any such person or his legal representative may be made a party or may be threatened to be made a party by reason of his being or having been a Director, Officer, Employee or Agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any Director, Officer, Employee or Agent may be entitled as a matter of law or which he may be lawfully granted.
