The undersigned, desiring to form a corporation under the Florida General Corporation Act, makes and subscribed to the following Articles of Incorporation.

ARTICLE I

The name of this corporation is **SRI GANESH , INC.**

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

CORPORATE PURPOSE

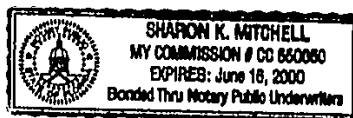
