ARTICLES OF INCORPORATION

OF

ARTICLE I.

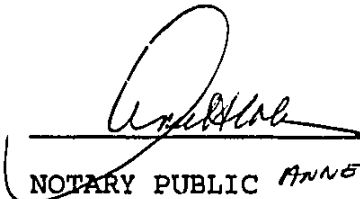

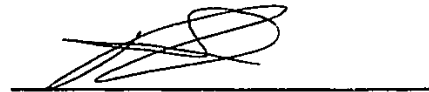

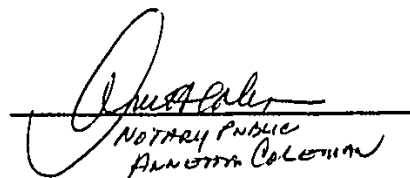
