The undersigned has executed the following Articles of Incorporation as incorporator under the laws of the state of Florida.

ARTICLE I. Name. The name of the corporation shall be Capital Punk Productions, Inc.

ARTICLE II. Term. The existence to the corporation shall commence upon filing of these Articles of Incorporation with the Office of the Secretary of State. The corporation shall have perpetual existence.

ARTICLE III. Purpose. The purpose of the corporation shall be to engage in and carry on the production, direction, and manufacture of motion pictures, to sell such motion pictures and associated intellectual property rights, to enter into contracts for distribution of said motion pictures, to deal in anyway whatsoever with the creation of motion pictures and all ancillary rights pertaining thereto, to promote film festivals, and to carry out all activities associated with and ancillary to the promotion of film festivals, and to transact any and all businesses authorized by the laws of the state of Florida.

ARTICLE IV. Shares. The corporation shall be authorized to issue 100 shares of voting common stock which shall have a par value of \$1.00 per share.

ARTICLE V. Resident Agent and Office. The Resident Agent of the corporation shall be Edgar Lee Elzie, Jr., who acknowledges acceptance at this position as Resident Agent by execution hereof.

ARTICLE VI. Initial Board of Directors. This corporation shall have one director initially. The number of directors may be increased or diminished from time to time by the by-laws but shall never be less than one. The names and addresses of the initial directors of this corporation are as follows:


