This corporation shall have that number of directors as set forth in the corporation's bylaws.

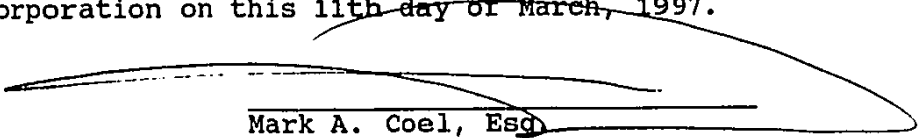
