ARTICLE I - NAME

The name of the corporation shall be FRI-KORSOU, INC.

ARTICLE II - CORPORATE EXISTENCE

The existence of this corporation shall commence on the 10TH day of March 1997; provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law for the commencement of corporate existence. The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The nature of the business and the objects and purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act, activity or business for which corporations may be organized under the laws of the State of Florida. Additionally, the corporation shall have all of the powers vested in a corporation organized under and existing by virtue of the laws of the State of Florida.


