

# ARTICLES OF INCORPORATION OF FRIENDS FULL SERVICE SALON, INC.

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of this corporation shall be: FRIENDS FULL SERVICE SALON, INC.

# ARTICLE II. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

#### ARTICLE III. CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.
