# ARTICLES OF INCORPORATION OF SOUTHERN GAS SERVICES, INC.

ARTICLE I

The name of the corporation is SOUTHERN GAS SERVICES, INC. ARTICLE II.

This corporation shall have perpetual existence, commencing as of the time these ARTICLES are filed by the Department of State, Division of Corporations.

ARTICLE III

This corporation is formed for the purpose of engaging in THE installation and servicing of liquid propane and natural gas systems. It shall also be empowered to transact and perform any and all lawful businesses for which corporations may be authorized under the Laws of the State of Florida.
