ARTICLES OF INCORPORATION OF LORI J. FARRINGER, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent as a real estate agent duly licensed to render such services in the State of Florida, hereby present these Articles for the formation of a corporation under the Professional Service Corporation Act, Florida Statutes 621.01 et.seq., and other laws of the State of Florida.

ARTICLE I .- NAME

The name of this corporation is LORI J. FARRINGER, P.A.

ARTICLE II.-NATURE OF BUSINESS

The general nature of the business to be rendered by this corporation is: the practice of real estate sales.

To engage in every phase and aspect of the business of rendering the same professional services to the public that any real estate agent, duly licensed under the laws of State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed and/or authorized under the laws of the State of Florida to operate in the general securities and life and health insurance policy business therein.

To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional services.
