ARTICLE I - NAME

The name of the Corporation shall be OVEA, INC.  
a Florida Corporation.

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of  
transacting any and all lawful business.

ARTICLE III - POWERS

This Corporation shall have all of the powers enumerated  
in the "Florida General Corporation Act", (Chapter 607,  
Florida Statutes).

ARTICLE IV - CAPITAL STOCK

and shall be exercised in the respective ratio with the  
number of shares held by each stockholder at the time of  
such issue bears to the total number of shares outstanding  
in the names of all stockholders at such time.

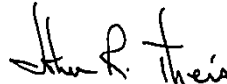
