

CORPORATE NAME

The name of this corporation is **ZELCO PROMOTIONS, INC.**

ARTICLE II
INITIAL PRINCIPAL PLACE OF BUSINESS

ARTICLE III
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage




