ARTICLES OF INCORPORATION OF IN-CERTS, INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is IN-CERTS, INC.

ARTICLE II

This corporation shall commence existence upon the filing of these Articles of Incorporation with the Department of State of Florida and shall thereafter have perpetual existence.
