**ARTICLES OF INCORPORATION OF
REGIONAL SERVICES, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is REGIONAL SERVICES, INC.

ARTICLE II

CORPORATE DURATION

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is upon approval of this charter.

ARTICLE III

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of investment.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be designated as "Common Shares" and shall have no par value.

ARTICLE V

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 2207 Durward Ride, Tallahassee, FL 32303, and the name of its initial registered agent at such address, is Larry C. Watts.

ARTICLE VI

DIRECTORS

The number of directors constituting the initial board of directors of the corporation is one. The name and address of each person who is to serve as a member of the initial board of directors is:

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

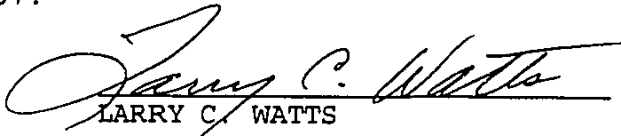
ARTICLE IX - INDEMNIFICATION

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

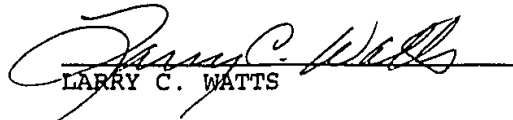

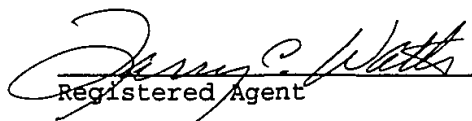
