

#### ARTICLE I. NAME

The name of this corporation is:

# ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these articles.

## ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited to home inspection for defects, building, and zoning violations.

# ARTICLE IV. CAPITAL STOCK

The stated capital of this corporation shall not be reduced by action of the board of directors when the reduction is not accompanied by any action requiring or constituting an amendment of the articles of incorporation.

# ARTICLE XIV. INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

## ARTICLE XV. AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
