ARTICLES OF INCORPORATION
OF
MEDICAL SERVICE ORGANIZATION OF PEMBROKE PINES, INC.

The undersigned, acting as incorporator of Medical Service Organization of Pembroke Pines, Inc., pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is:

The name and street address of the incorporator is:




