### ARTICLES OF INCORPORATION

Six Star Cruises, Inc., a Florida corporation

The undersigned subscriber to these Articles of Incorporation in a natural person, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I. NAME

The name of this corporation is: Six Star Cruises, Inc., a Florida corporation.

## ARTICLE II. NATURE OF BUSINESS

The general nature of the business and the object and purpose to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as a natural person might or could do, viz:

- 1. To promote, organize, plan and conduct trips, tours, and excursions by ship, aircraft, or motor-vehicles for individuals or groups of individuals to any part of the world. To provide for the transportation of individuals, the transportation of groups of individuals in connection with the conduct of a general travel and tourist agency, and to provide or procure hotel and other accommodations for comfort, convenience, and entertainment of individuals or groups of individuals who are members of any trip or tour conducted or promoted by the Corporation.

Statutes, it being the intent that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of the capital stock which this corporation shall be authorized to have outstanding at any time is ONE THOUSAND (1,000) shares at \$1.00 par value.

## ARTICLE IV.

The amount of the capital with which this corporation shall begin business is not less than FIVE HUNDRED and NO/100 DOLLARS (\$500.00).

#### ARTICLE V.

The existence of this corporation shall be perpetual.

### ARTICLE VI.
