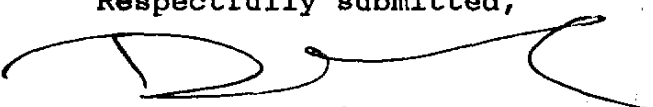
Please find enclosed our check for \$150.00 and our completed 1998 Profit Corporation Annual Report.
