Gentlemen:

I am writing to you in regard to the Annual Report for the above corporation which was not filed by the May 1, 2001 deadline.

Michael F. Moyer was the principal and only acting officer in the corporation. It was a one-man operation to the extent that only he signed the checks, paid the bills, filed the paid invoices and took care of all incoming mail and all correspondence.

Mr. Michael F. Moyer was in an automobile accident in April 2001 on Easter Sunday on I-95 in Fort Lauderdale, Florida when his automobile flipped over. He lost his left arm from the elbow down, was in a coma for a long period of time and could not communicate. He still is in the hospital and his recovery from the trauma will take many more months of therapy.

A consequence of this accident is that the annual report did not get filed timely by May 1, 2001. I had your office send me a blank form after I was called into the matter in early May for other legal reasons. I contacted the Department of State office on May 9, 2001 to get information on the officers. I was informed at that time that the annual report had not been filed.

On behalf of the corporation and Mr. Moyer, I request that you consider this reasonable cause and accept the filing of the annual report and the enclosed check for \$150.00. Your courtesies in this matter will be greatly appreciated. Thanking you in advance, I remain
