

ARTICLE ONE

The name of the corporation is **4 STAR RENT TO OWN, INC.** The principal address of the corporation is: 201 SW 27 Ave., Ft. Lauderdale, FL 33312.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE
