

#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do heraby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the corporation is **FIRESTICK CONTRACTORS**, **INC**.

#### **ARTICLE TWO**

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is March 10, 1997.

#### ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of construction.
- 2. To transact any other lawful business for which a corporation may be formed and allowed to do under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the aforegoing.

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of \$ .10 per share.

## ARTICLE EIGHT


