

ARTICLES OF INCORPORATION
OF
PARK CENTRAL SUPPLY, INC.

ARTICLE ONE

The name of the corporation is **PARK CENTRAL SUPPLY, INC.** The principal address of the corporation is: 7410 N.W. 12 Street, Plantation, Florida 33313.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE
