ARTICLES OF INCORPORATION  
OF  
INTERNATIONAL TALENT PROMOTIONS, INC.

ARTICLE I — NAME

The name of this corporation is INTERNATIONAL TALENT PROMOTIONS, INC. The principle place of business and the mailing address of this corporation shall be: 3984 SW 2nd Street, Miami, Florida, 33134.

ARTICLE II — DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III — PURPOSE

This corporation is organized primarily for the purpose of acting as purchaser and/or broker for professional performing artists for engagements to be performed outside of the United States of America, primarily in Central and South America, and transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV — CAPITAL STOCK

This corporation is authorized to issue 1000 shares of no par value common stock which shall be designated as "Common Stock".

#### ARTICLE V — PRE-EMPTIVE RIGHTS

Pursuant to Florida Statutes §607.0630, as amended from time to time, every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI — INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VII — INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) Director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one (1) Director nor more than three (3). 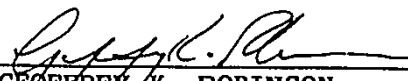
