ARTICLES OF INCORPORATION OF ELDORADO WIRELESS, INC.

The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

EFFECTIVE DATE

ARTICLE ONE NAME

The name of the corporation is Eldorado Wireless, Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.
