ARTICLE I

NAME AND PLACE OF BUSINESS - The name of this corporation is COMMUNITY HOPE CENTER, INC. Its principal place of business shall be 516 South Tyndall Parkway, Suite 203, Panama City, Bay County, Florida.

ARTICLE II

DURATION - This corporation shall have perpetual existence, and shall commence corporate existence at the time of filing of these Articles of Incorporation by the Department of State.

ARTICLE III

PURPOSE - The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States of Florida.

ARTICLE IV

OFFICERS - The Board of Directors may elect or appoint a President, Vice President, Secretary and Treasurer and such other officers as they may determine. Each officer shall hold office until the Annual Meeting of the Board of Directors and until his successor has been duly elected and qualifies. At a minimum, there shall be the offices of President and Secretary/Treasurer.

ARTICLE V

INITIAL BOARD OF DIRECTORS - The initial Board of Directors shall consist of one member. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one nor more than five. ARTICLE VI

BYLAWS - The bylaws of the corporation shall be made, altered, and repealed by the Board of Directors, except that the Board may not amend or repeal any bylaws in which control is vested exclusively in the stockholders. All bylaws of the corporation shall be subject to alteration or repeal, and any new bylaws may be made by a majority vote of the stockholders entitled to vote in the election of director, at a special

meeting of the stock holders called for such purpose.

#### ARTICLE VII

INITIAL REGISTERED OFFICE AND AGENT - The initial registered office of this corporation shall be 516 South Tyndall Parkway, Suite 203, Panama City, Bay County, Florida, and the initial registered agent of this corporation at such office shall be Daren D. Hatfield, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

#### ARTICLE VIII

CAPITOL STOCK - The maximum number of shares which this corporation is authorized to have outstanding at any time is 100 shares of common stock having no par value.

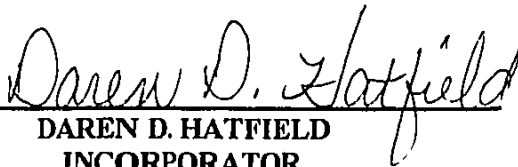

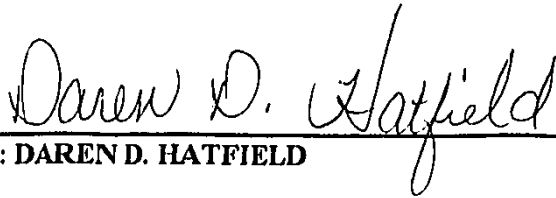
