ARTICLE I

SLUMBARY OF STATE TALLAHASSEE, FLORIDA

<u>NAME AND PLACE OF BUSINESS</u> - The name of this corporation is COMMUNITY HOPE CENTER, INC. Its principal place of business shall be 516 South Tyndali Parkway, Suite 203, Panama City, Bay County, Florida.

ARTICLE II

<u>DURATION</u> - This corporation shall have perpetual existence, and shall commence corporate existence at the time of filing of these Articles of Incorporation by the Department of State.

ARTICLE III

<u>PURPOSE</u> - The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States of Florida.

ARTICLE IV
