**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The Name of the Corporation is NETWORKED KNOWLEDGE SYSTEMS, INC.
2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on the 15 day of April, 2001, in the manner prescribed by the Florida Business Corporation Act:

Article II is hereby amended to read as follows:

“The Corporation shall have the authority to issue 10,000,000 shares of common stock, no par value”

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
